ORDINANCE NO. 5256

ORDINANCE AMENDING SUBDIVISION (A) OF SECTION 2.02.060 OF THE SANTA CRUZ COUNTY CODE RELATING TO THE COMPENSATION OF THE BOARD OF SUPERVISORS

The Board of Supervisors of the County of Santa Cruz ordains as follows:

SECTION I

Subdivision (A) of Section 2.02.060 of the Santa Cruz County Code is hereby amended to read as follows:

(A) The biweekly compensation for members of the Board of Supervisors shall be \$4,846.58 effective January 7, 2018; \$4,955.63 effective September 22, 2018; \$5,067.13 effective September 21, 2019; and \$5,181.14 effective September 20, 2020.

SECTION II

This ordinance shall take effect on the 61st day after the date of final passage.






