RESOLUTION NO. 35-2018

On the motion of Supervisor Caput  
duly seconded by Supervisor McPherson  
the following resolution is adopted:

RESOLUTION OF TO MODIFY OLD RANCH ROAD BOUNDARY AND CREATE AN  
ADDITIONAL ZONE BLUE MOUNTAIN RIDGE ZONE WITHIN COUNTY SERVICE  
AREA NO. 23 OLD RANCH ROAD

WHEREAS, this Board, by its Resolution No. 13-2018 adopted January 09, 2018, authorized to modify the County Service Area (CSA) No. 23 Old Ranch Road boundary and create an additional Zone Blue Mountain Ridge (BMR), within to provide road maintenance and operation services; and

WHEREAS, CSA No. 23, Old Ranch Road rates are currently based on zones of benefit; and

WHEREAS, pursuant to California Government Code Sections 25217 et seq., the Board now considers it necessary and desirable to modify the boundaries of CSA No. 23, Old Ranch Road, and create an additional Zone BMR, to enable the homeowners to contribute toward benefit assessments for the Zone BMR and to allow the ability of collecting benefit assessments in the future to be utilized solely on BMR Zone.

NOW, THEREFORE, the Board of Supervisors of the County of Santa Cruz resolves and orders that:

1. The geographic boundaries of each current zone of CSA No. 23, Old Ranch Road are reflected on the attached map (Exhibit A); and
2. A public hearing was held on February 27, 2018, at the Board of Supervisors Chambers, 701 Ocean Street, 5th Floor, Santa Cruz, CA 95060, on the proposed boundary modification of the CSA No. 23, Old Ranch Road and the proposed establishment of an additional Zone BMR, to enable the homeowners within to contribute toward benefit assessments within Zone BMR and for the ability of property owners on BMR to collect benefit assessment in the future to be utilized solely on BMR; and
3. At such hearing, the testimony of all interested persons or taxpayers for or against the boundary modification and establishment of an additional zone within the area may be heard; and
4. The collection of the proposed assessment shall be by the County of Santa Cruz on behalf of Zone BMR within CSA No. 23, Old Ranch Road in the same manner, and subject to the same penalties as other fees, charges, and taxes fixed and collected by or on behalf of all CSAs. The County may deduct its reasonable costs incurred for that service before submittal of the balance to the account of Zone BMR within CSA No. 23, Old Ranch Road.
