On the motion of Supervisor Leopold
duly seconded by Supervisor McPherson
the following resolution is adopted.

**RESOLUTION AUTHORIZING APPLICATION FOR, AND RECEIPT OF,
INVESTMENT IN MENTAL HEALTH WELLNESS ACT OF 2013 ROUND 2
TRIAGE GRANT FUNDS**

WHEREAS, the State of California Mental Health Services Oversight and Accountability Commission (Commission) is soliciting Applications for Investment in Mental Health Wellness Act of 2013 (Act) Round 2 Triage Grant dollars aimed at crisis triage services for adults, age 22 and above, and Transition Age Youth, ages 16 to 25; and

WHEREAS, the County of Santa Cruz desires to submit a Grant Application for Act Round 2 Triage Grant funds and will submit a Grant Application as described in Notice of Funds Availability and Release of Request for Applications (RFA) released by the Commission; and

WHEREAS, the Commission is authorized to provide up to \$16 million annually from the Act through the RFA for the hiring of mental health triage personnel to provide a range of triage services to individuals with mental illness or emotional disorders requiring crisis intervention.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, that the County of Santa Cruz Board of Supervisors hereby authorizes and directs the Health Services Agency to apply for and submit to the Commission the Grant Application for Act Round 2 Triage Grant funds.

In connection with the Act Round 2 Triage Grant, if the application is approved by the Commission, the County is authorized to enter into, execute, and deliver a State of California Standard Agreement (Standard Agreement), and any and all other documents required or deemed necessary or appropriate to evidence and secure the Act Round 2 Triage Grant, the County's obligations related thereto, and all amendments thereto (collectively, the "Act Round 2 Triage Grant Documents").

Resolution 33-2018

The County shall be subject to the terms and conditions as specified in the Standard Agreement, the Act Round 2 Triage Grant RFA, and any applicable Act guidelines published by the Commission. Funds are to be used for allowable project expenditures as specifically identified in the Standard Agreement. The application in full is incorporated as part of the Standard Agreement. Any and all activities funded, information provided, and timelines represented in the application will be enforceable through the executed Standard Agreement. The County hereby agrees to use the funds for eligible uses in the manner presented in the application as approved by the Commission and in accordance with the Act Round 2 Triage Grant RFA and the Act Round 2 Triage Grant Application.

The County Executive or designee is authorized and directed to execute the County of Santa Cruz Act Round 2 Triage Grant Application, the Act Round 2 Triage Grant Documents, and any amendments thereto, on behalf of the County as required by the Commission for receipt of the Act Round 2 Triage Grant.


