Dear Chairman Caput & County Supervisors,

It is now 7 months since the covid-19 emergency was declared. Over these 7 months, I have sent you an abundance of information - evidence from scientists, medical doctors, epidemiologists and other experts - ALL questioning the current "emergency" narrative. Most saying that there is in fact no health emergency.

Even the CDC has revised the covid related death counts, showing that only a small fraction of the total deaths were caused by covid alone - and that 96% involved numerous other chronic co-morbidities.

The Santa Cruz County covid death statistics reveal the same information. All of the 12 persons who were listed as covid related deaths had additional chronic co-morbidities, including leukemia, obesity, heart disease. Four were in their 90's, and 3 in their 70's.

For I time I was able to obtain this information via Freedom of Information Act Public Records Requests, but suddenly I have been told this information is no longer available, for privacy reasons. Why? Why is information about the specifics of co-morbidities being hidden from the public?

Coincidentally, all attention has now been turned to the PCR test and cases are the only metric being considered. The creator of this test, Kary Mullis, has stated that it was never intended to be used for diagnostic purposes. In other words, this information is meaningless - the same information that is being used to enforce mandates, close businesses, and destroy our community.

- Detection of viral RNA may not indicate the presence of infectious virus or that 2019-nCoV is the causative agent for clinical symptoms.
- The performance of this test has not been established for monitoring treatment of 2019-nCoV infection.
- The performance of this test has not been established for screening of blood or blood products for the presence of 2019-nCoV.
- This test cannot rule out diseases caused by other bacterial or viral pathogens.

And so I am left with the question, given that you all seem to be intelligent, compassionate human beings - Why has nothing changed? Why are we still under the oppression of this non-existent health emergency? Why are you allowing the health and wellbeing of our community to be destroyed under the guise of public health?

Why have you been silent when asked to provide proof that such an emergency actually exists?

I can think of only 3 possibilities:

- 1) You never read any emails sent by the community.
- 2) Your minds are made up and you don't care what the community thinks/wants.
- 3) You are being coerced/threatened in some way.
- 4) You are receiving payment or some other reward.

I can think of no other possible reason for completely ignoring the community's repeated requests for an independent forum - for an open dialogue where other expert opinions are considered.

Any one of these possibilities is a violation of your Oath of Office, which is a Federal criminal offense. I hope you will give this a great deal of thought going forward.

There are many lawsuits pending and you will be held accountable very soon.
